Ultimate Power Muff Quads

Increases Hearing

- Up to nine times with 50 dB of power for the highest rating in the industry.

Protects Hearing

- Sound Activated Compression (SAC) circuit helps protect hearing from harmful loud sounds, by reducing the amplification of those sounds to a safe level.
- Noise Reduction Rating (NRR) of 27 dB.

Volume Controls & Directional Sound

- Two independent volume controls allow for total adjustment of the four wind resistant high frequency microphones.

Hearing Enhancement

- Four Hi Gain Omni Directional Microphones.
- Independent Adjustable Frequency Tuning.

Adjusting The Headband

Your Ultimate Power Muff Quad comes with an independent headband and ear muffs adjustments. Size the muffs to comfortably fit your head by sliding the ear cups in or out of the metal frame. The ear cups should fit comfortably, completely surrounding your ears to get the perfect acoustic seal.

Replacing The Battery

The battery compartments are located on the outside of each ear. The compartment is designed for easy access. Remove the battery from compartment and replace with two new size AAA Alkaline batteries. Note the direction of the positive (+) and negative (-) poles.

Trouble-Shooting Your Ultimate Power Muff Quad

If you experience problems, see possible fix below.

| Symptom | Possible Cause | Possible Fix |
|--------------------------------|----------------------|-----------------|
| Dead | Battery is dead | Replace battery |
| Not Loud Enough | Battery is dead | Replace battery |
| Intermittent (goes on and off) | Battery is defective | Replace battery |
| Not Clear, Distorted | Low battery | Replace battery |
| Motor-boating Sound | Low battery | Replace battery |

Identifying Muff Components



If Your Ultimate Power Muff Quad Whistle

Whistling may sometimes occur when you wear your Ultimate Power Muff Quad with the power tuned on. Whistling generally occurs if the volume level is set too high. Turn the volume level down until the whistling stops.

Caring For Your Ultimate Power Muff Quad

Remember that your Ultimate Power Muff Quad is a quality instrument and should be treated in the same careful manner as any other precision-engineered device.

1. Never allow any liquid to enter the Ultimate Power Muff Quad as this may damage the components within the device.
2. Do not store your Ultimate Power Muff Quad in any location which would expose it to excessive heat (for example; in direct sunlight, car dashboards, heaters or radiators).
3. Be careful not to drop your Ultimate Power Muff Quad as this may damage its components.
4. Never insert any foreign objects into your Ultimate Power Muff Quad. This could result in serious damage to the instrument.
5. Never permit solvents to come into contact with your Ultimate Power Muff Quad as this can damage the units.
6. Clean your Ultimate Power Muff Quad by wiping with a damp cloth moistened with a mild cleanser.

LIMITED WARRANTY

Walker's warranties this product to the original purchaser to be free from defects in materials and workmanship, under normal use and conditions for a period of one year parts from the date of purchase.

Under this warranty, this unit will be replaced or repaired at our option. Copy of original receipt or gift receipt, is required for any warranty service. To enact the warranty, the customer is required to contact our Customer Service Group at 877-269-8490 to receive an Return Authorization (RA) number **PRIOR** to sending the product back.

This warranty is void if any of the following occur:

1. The unit is not accompanied by a copy of the receipt or gift receipt from the original purchaser.
2. The unit has been tampered with, opened or punctured.
3. The unit has been immersed in water or other liquids, allowed to be filled with dirt or dust, or otherwise physically abused.
4. The one year limited warranty has expired. Please inquire about other options from your Customer Service Representative.

This shall be the exclusive written warranty of the original purchaser and neither this warranty nor any other warranty, expressed or implied, shall extend beyond the 12-month period listed above.
